## SECTION 17.1 HIGHWAY REGULATORY ACT ADOPTED.

Pursuant to the authority conferred by L.R.S. Title 32:41(c) the municipality adopts the provisions of L.R.S. Title 32, Chapter 1 (Louisiana Highway Regulatory Act), and all regulations of the State Department of highways and the director of public safety adopted pursuant thereto, except for such provisions and regulations as by their nature can have no application, and except as otherwise provided in this code.

## SECTION 17.2 SUPERVISION, REGULATION, ETC., BY CHIEF

The Chief of Police shall supervise and regulate all traffic on the public streets; enforce the provisions of this chapter, investigate the public highways and effect methods and practices relative thereto as in his judgment and experience he deems advisable; and enforce them as an exercise of the police power of the municipality.

## SECTION 17.3 MAKING AND ENFORCING REGULATIONS

The Chief of Police is hereby empowered to make and enforce regulations necessary to make effective the provisions of this chapter and to make and enforce temporary regulations to cover emergencies and special conditions.

## SECTION 17.4 AUTHORITY TO PLACE SIGNS, SIGNALS AND MARKINGS

The Chief of Police is authorized, and as to those signs and signals required herein, directed to place and maintain or cause to be placed and maintained all traffic signs and signals with the advice, consent and approval of the board.

## SECTION 17.5 FREE FLOW OF TRAFFIC, OBSTRUCTION PROHIBITED

All persons are prohibited from engaging in driving procedures which obstruct the free flow of traffic in, around, over and through the streets, alleyways and other public ways. Any person is prohibited from stopping his vehicle (except at a stop signal or stop sign, or to honor another driver's right of way, or in an emergency situation) in a manner as to obstruct the free and orderly flow of traffic by the maneuver, or to engage in unduly slow driving procedures so as to obstruct the free flow of traffic or to needlessly 'circle the block' or dawdle, or make unnecessarily rapid accelerations and decelerations or to in any other manner constitute a traffic nuisance or hazard.

## SECTION 17.6 SPEED LIMITS ESTABLISHED

(a) No person shall operate any motor vehicle or tractor upon any of the streets and highways at a greater speed than is reasonable and proper having regard to the width, traffic, and use thereof, or so as to endanger the property of life or limb of any person.
(b) The speed for the streets or portions of streets are hereby established for those streets, or portions of streets listed in appendix I-A hereby incorporated herein.

## SECTION 17.7 TRAFFIC SIGNALS AT CERTAIN INTERSECTIONS

Official traffic control signals shall be erected (or if heretofore erected are hereby ratified) at the intersections in appendix I-B hereby incorporated herein. Traffic at designated intersections shall be directed by signals.

## SECTION 17.8 ONE-WAY STREETS ESTABLISHED.

Upon those streets and parts of streets and in those alleys listed and described in appendix I-C hereby incorporated herein, vehicular traffic shall move only in the indicated direction when signs indicating the direction of traffic are erected and maintained at every intersection where movement in the opposite direction is prohibited.

## SECTION 17.9 LEFT AND/OR RIGHT TURNS REGULATED

It is unlawful for the operator of any motor vehicle, traveling upon the first-named highway at any of the intersections specified in appendix I-D hereby incorporated herein, in the direction or directions herein indicated in each case, to make a left turn and/or right turn at the intersection, as therein indicated.

SECTION 17.10 STOP INTERSECTION ESTABLISHED.

The intersections specified in appendix I-E hereby incorporated herein, are established as stop intersections, and official stop signs shall be erected (or are hereby confirmed if heretofore erected) in a position as to face traffic approaching the second-named street upon the first-named street, in the direction or directions therein indicated. All motor vehicles approaching the intersection upon the first-named street in the direction or directions therein indicated in each case, shall come to a full stop, within a reasonable distance, before entering the intersection.

## SECTION 17.11 YIELD RIGHT OF WAY INTERSECTIONS ESTABLISHED

The intersections specified in appendix I-F hereby incorporated herein, are established as yield-right-of-way intersections and official yield signs shall be erected (or are hereby ratified if heretofore erected) in a position as to face traffic approaching the second-names Street from the first-named street, in the direction or directions therein indicated. All vehicles and tractors approaching the intersection upon the first-named street, in the direction or directions therein indicated, shall yield the right of way to any motor vehicle in the intersection or approaching on the second-named street so closely as to constitute an immediate hazard during the time that the operator of the vehicle or tractor is moving across or within the intersection.

## SECTION 17.12 VEHICLE WEIGHT LIMITS ESTABLISHED.

It is unlawful for any person to operate on any street any motor vehicle, or other vehicle, tractor, trailer, or tractor trailer combination, having an aggregate or gross width equal to or greater than the width specified for that vehicle in appendix I-H hereby incorporated herein, on the streets and/or highways or portions of streets and highways respectively described therein.

## SECTION 17.13 VEHICLE WIDTH LIMITS ESTABLISHED

It is unlawful for any person to operate on any street any motor vehicle, or other vehicle, tractor, trailer, or tractor- trailer combination, having an aggregate or gross width equal to or greater than the width specified for that vehicle in appendix I-H hereby incorporated herein, on the streets and/or highways or portions of streets and highways respectively described therein.

## SECTION 17.14 VEHICLES TO BE PARKED WITHIN MARKED SPACES

Whenever a space is marked off on any roadway for the parking of an individual vehicle, every vehicle there parked shall be parked within the lines bounding that space.

## SECTION 17.15 PARKING PROHIBITED AT ALL TIMES IN CERTAIN LOCATIONS.

It is unlawful for the owner or operator of any motor vehicle or other vehicle to park the vehicle in any of the places on the streets and alleys specifically designed in appendix Il-A hereby incorporated herein.

## SECTION 17.16 PARKING PROHIBITED IN CERTAIN LOCATIONS, CERTAIN DAYS AND HOURS.

It is unlawful for the owner or operator of any motor vehicle or other vehicle to park the vehicle in any of the spaces on the days and between hours indicated and specified in appendix Il-B hereby incorporated herein.

It is unlawful for the owner or operator or any motor vehicle, or other vehicle to park the vehicle or allow the vehicle to remain in any of the places on the streets and alleys at any time on the days and between the hours indicated and specified in appendix Il-C hereby incorporated herein.

## SECTION 17.18 SPECIAL PURPOSE PARKING ZONES ESTABLISHED, PARKING OTHERWISE PROHIBITED.

It is unlawful for the owner or operator or any motor vehicle, or other vehicle to park the vehicle or allow the vehicle to remain parked in any location on the streets and alleys established and designed as special purpose, parking zones indicated and specified in appendix II-D, hereby incorporated herein.

## SECTION 17.19 INOPERATIVE MOTOR VEHICLES

It is unlawful for any inoperative motor vehicle to be left standing on the streets, sidewalks, alleys or other municipal property for a period of more than 24 hours.

## SECTION 17.20 APPROACH OF EMERGENCY VEHICLE

Upon the approach of any police or fire department vehicle, or hospital ambulance, giving audible signal by an appropriate device, the driver of every other vehicle shall immediately drive to a position as near as possible and parallel to the right hand side of the Street or highway, clear any intersection, and shall stop and remain there, unless otherwise directed by police or traffic officer, until the police or fire department vehicle or hospital ambulance has passed.

## SECTION 17.21 FOLLOWING AND PARKING TOO NEAR FIRE APPARATUS PROHIBITED.

It is unlawful for the driver of a vehicle, other than one on official business, to follow any fire apparatus traveling in response to a fire alarm, closer than 600 feet, or to drive and/ or park the vehicle within the block, or within 300 feet of the place where the fire apparatus has stopped to answer a fire alarm.

## SECTION 17.22 TRAINS, BLOCKING CROSSINGS: SPEED LIMIT

(a) It is unlawful for any railroad company or corporation, its successors or assigns, any trainman, conductor, brakeman, flagman or other member of the train crew or any other person, to operate or permit operation of any train, locomotive, or any other vehicle so as to obstruct, use or occupy any crossings on any public street for more than 15 minutes at one time.
(b) It is unlawful for any person to operate or permit operation of a railroad train within the corporate limits at a speed in excess of $35 \mathrm{~m} . \mathrm{p} . \mathrm{h}$.

## SECTION 17.23 BICYCLE OPERATION REGULATED

(a) As used in this chapter the term vehicle shall include bicycles, motor bikes, motor scooters, motorcycles and mopeds.
(b) The vehicles listed in (a) above shall not be ridden over or upon the sidewalks of this
municipality;
(c) Operators of vehicles listed in (a) above shall in all respects comply with existing state laws regarding registration, operation, and safety.

## SECTION 17.24 SCHEDULE OF FINES AND COURT COSTS FOR VIOLATIONS OF HIGHWAY REGULATORY ACT.

Section 1. Traffic Fines. The schedule of fines and court costs for violation of Highway Regulatory Act set forth below are hereby adopted. Such fines and court costs are in addition to any assessments or surcharges imposed by the State of Louisiana or other governmental authorities for any violation. Such assessments shall be added to the fines and costs set forth below. (Amended Section 17.24 A-T - Ordinance 7 of 2019 - Effective February 12, 2019)

## APPENDIX I

## I-A SPEED LIMITS ESTABLISHED

1. The speed limit of motor vehicles on all streets and highways in the Town of Blanchard, except as hereinafter provided, shall be thirty-five ( 35 m. p.h.) miles per hour.
2. The speed limit of motor vehicles in zones designated and marked as school zones in the Town of Blanchard shall be twenty-five ( $25 \mathrm{~m} . \mathrm{p} . \mathrm{h}$.) miles per hour during school hours 7:30 to 8:30 AM and 2:30 to 3:30 PM. School zones are established adjacent to the sidewalks
located on the following roads and shall be so marked.
a. Blanchard-Latex Road
b. Alexander Avenue
c. Pine Hill Road
d. Daugherty Avenue
e. Birch Street
e. Jodie Street
3. The speed limit for motor vehicles on the state highways through the Town of Blanchard shall be established by the State of Louisiana, and posted by the Department of Highways.
4. The streets of Warriner Road and Sand Valley Rd. running east and west from Main St. (Hwy 173) to the Wasson Road and Kay Ave. intersection is designated as a truck route and the speed limit of motor vehicles shall be 25 MPH.
5. The speed limit for motor vehicles shall be 25 MPH on all streets west of the K.C.S. Ry. Tracks, running east and west, north and south (with the exception of Daugherty and Alexander Ave. which will remain 35 MPH ) in the Town of Blanchard, LA.
6. The speed limit for motor vehicles shall be 25 MPH on Phelps Ave. from North Main Street (HWY 173) east, to Sand Valley Road.
7. The speed limit on portion of Roy Road from the town limits of the Town of Blanchard east to the intersection of Roy Road and LA Highway 538 is reduced from 50 miles per hour to 35 miles per hour. (Adopted June 14, 2016 - Ordinance 3 of 2016).

## APPENDIX I

## I-B TRAFFIC CONTROLS SIGNALS

(1) A traffic control signal is established at the intersection of Alexander and Main Street.

## I-C ONE-WAY STREETS

That portion of Birch Street from Pine Hill Road to Jodie Street shall be "one way" heading south and west from Pine Hill Road to Jodie Street during the hours of 7:00 a.m. to 5:00 p.m. Monday thru Friday when Blanchard Elementary School is in session beginning the first day of school for the 2013-2014 year and thereafter. (Adopted April 9, 2013 - Ordinance 3 of 2013).

1. The following streets and roads are designated as truck routes for commercial vehicles in the Town of Blanchard, LA:
